

MINUTES OF A NOMINATION MEETING OF PRINCIPALS AND ELECTORS 7PM, THURSDAY 5TH AUGUST 2021

The Connétable was unable to attend the Meeting and Procureur du Bien Public, Peter Germain, chaired the Assembly in her absence. The Procureur Germain welcomed all present and reminded the Assembly that they could sign the Attendance Book at the end of the meeting if they so wished. It was noted that 27 parishioners attended the Assembly.

Apologies were received from Connétable Karen Shenton Stone, Deputy Stephen Luce, Colin and Paulette de la Haye, Centenier Roland, Vingtenier Cobden, Vingtenier Falle, Megan Gaudin. The Convening Notice was read by the Parish Secretary.

1. To elect one Centenier to complete a three-year term of office expiring June 2024.

Pursuant to an Act of the Royal Court dated 23rd July 2021, whereby it was ordered that an election be held for Centenier, this nomination meeting has been called to elect one Centenier to complete a three-year term of office expiring in June 2024.

The Procureur Germain confirmed that a nomination form had been received for Alan Richard Phillips which was completed by proposer Paul Gaudin, and nine seconders who are electors of the Parish. Procureur Germain invited Paul Gaudin to address the Assembly.
