

## MINUTES OF AN ASSEMBLY OF PRINCIPALS, OFFICERS AND ELECTORS

An Assembly of Principals, Officers and Electors of the Parish of St Martin was duly convened and held in the Public Hall on Thursday 2<sup>nd</sup> March 2023 at 7.00pm.

The Connétable welcomed all present and reminded the Assembly that they could sign the Attendance Book at the end of the meeting if they so wished. It was noted that 15 parishioners attended the Assembly.

Apologies were received from Deputy Stephen Luce. The Convening Notice was read by the Parish Secretary.

## Item 1

Receive and if deemed advisable, approve the Minutes of the Parish Assembly held on 26th January 2023 and approve the Minutes of a Nomination Meeting held on 26th January 2023.

The Connétable stated that the application has been made to the Bailiff for this permit and this Assembly has been requested by the Bailiff's Chambers in order to seek comments and approval from Parishioners. The Connétable then asked the Assembly for a Proposer for this application. Mrs Jane Bravery requested that this application be approved by the Assembly. In her proposal speech, Mrs Bravery stated that she had known the applicant, Victoria Boarder, for over twenty years. She further stated that having seen Mrs Boarder progress with her fresh fish company that she has seen that she has the vision to transform any business that she is involved in, encouraging all contractors to participate. The current business of providing picnic hampers to businesses and

the general public would like to now offer a glass of wine with this service, providing a special treat for islanders and visitors alike. The application was seconded by Oliver Le Gresley.

Connétable Stone stated that both the Fire Safety Officer and the Environmental Health Officers were aware of this application. The Connétable then asked for any questions from the Assembly.

Procureur Germain queried the name of the applicant (Anneville Organic Farm). The Parish Secretary advised that this was the name on the documents forwarded from the Government of Jersey officer and that it would be confirmed prior to the Licensing Assembly. Mrs Victoria Border stated that is should be Binney and Boarder (the name of the organisation). Post Assembly it was confirmed that this was correct – the name of the applicant is Binney and Boarder. Mrs Boarder also confirmed that the application for this licence was to enable the business to offer wine with picnic hampers if requested.

With no further questions and comments, a show of hands showed that the application was unanimously approved.
