#### La Vallée de Rozel - Stone

## Gutters

Works due to commence on 5<sup>th</sup> February for 10 days weather permitting.

# La Rue Potirons

Hedgerow planting will be completed by the Lands Team before the Spring

# Le Mont Gabard

It was noted that the matter was ongoing and the owner of Beaulieu was due to give the Parish an update towards the end of January. None received so will CA chase second week of February

#### Field MN410

It was noted that more parking spaces are required. KSS advised that the former owner of the site had requested that more housing for the elderly is made available. KSS to review updated plans.

# Field MN494

Appeal date 13.02.25. KSS to request item on agenda early morning or late afternoon due to her attendance required at a former Constable's wife's funeral at 2pm that day. CA to attend.

## Footpath by La Rue du Pavillion

It was noted that a tree has fallen blocking the path. JM to contact tenant to requested removal.

# **Pothole Repairs**

The Committee agreed to visit the following roads at the end of the meeting to ascertain what pothole repair work was required:

- Le Mont des Ormes
- La Longue Rue
- La Rue des Raisies
- La Rue Baudains
- La Rue de la Chouquetterie

#### Branchage - Clair Val

It was agreed that a letter/email be forwarded to the owners of Clair Val requesting branchage is completed within 7 days or a fine will be imposed.

#### **Drains**

Rue de Neuilly – RLC to speak with property owner to seek view of jetting the drain. Rue de la Mare des Reines it was agreed that the gutter needs cleaning by Lands Team. It was noted that the Committee were appreciative of the Lands Team inspecting all drains prior to the storm on 29.01.25. This inspection prevented possible flooding of roads.

### **Footpath Creation**

The Chair is awaiting a response from the owner to arrange a date to meet. CA to attend meeting.

#### Missing Sign

Replacement sign required to be erected.

## Fliquet - Pothole Review

Jersey Property Holdings contacted and awaiting response from Infrastructure Department.

#### Rue de la Fosse a Gres

MJ advised that he had cleared the surface water with the required equipment. KSS thanked him for taking this action.

#### **Bus Shelter Bin**

It was noted that a Parishioner had collected a bag of rubbish from the bus shelter opposite the Royal pub. Litter continues to accumulate at this site.

# Mont de la Guerande

Ongoing work on gully. Work will be completed by Lands Team when time allows.

### 4. La Rue St Julien

It was noted that the resurfacing works had been completed as part of the drainage repairs.

## 5. Rue de Bassacre

It was agreed that the kerb would remain as is.

# 6. Le Mont des Orme

Verge east of Rock Cottage to be inspected post meeting.

#### 7. La Chasse des Demoiselles Bandinel

It was noted that complaints have been received regarding the mud left on the road by two contractors working on two sites. MJ to speak with them and request clean up.

Rue des Raisies – it was noted that a paving stone at the Public Hall end of the road needs resetting. KSS to speak with Procureurs and arrange repair.
