



**Minutes of a Meeting of the Roads Committee held on
Monday 3rd November 2025 at 9am
Public Hall - Parish of St Martin**

1. Agenda, Apologies and Conflicts of Interest:

No conflicts of interest were noted.

2. Minutes of Previous Meetings held on Monday 1st September 2025.

The Minutes were approved and signed by the Connétable.

3. Action Points & Matters Arising:

Le Mont Gabard

It was noted that the report from RGA Engineers had been sent to the Royal Court and the Parish would await a response from the appointed Jurat. In the interim the item would be removed from the Agenda.

Parish Roads – Powers of Committee to review new openings onto Parish roads

It was noted that KSS had raised the matter with the Assistant Environment Minister, Connétable Mike Jackson, and was awaiting his response.

La Rue de la Solitude

It was noted that a meeting had recently been held with Marc Poingdestre from Infrastructure & Environment, and it had been agreed to install a number of small timber posts to safeguard access to the road drain.

Weed Growth along Parish Road

The Committee reviewed the quote from Vautier Municipal and it was agreed to accept the quote and request Vautier Municipal to undertake the works at the beginning of April 2026.

New Sewage Tank at Maufant

It was noted that the Traffic Section of Infrastructure & Environment had recommended that the traffic management should be discussed with the Parish but regrettably this had not happened to date. It was noted that one of the conditions of the Planning consent was the drafting of a traffic management plan.

The Committee agreed that it was unfortunate that the Parish was not being actively consulted on such issues and remained concerned that the Planning Officers and independent Inspectors were not giving sufficient consideration to the Parishes.

Review and Clean Storm Water Gullies

The Committee highlighted the need for the storm water gullies to be regularly checked and cleaned out particularly during the winter months.

Development of Field 410

It was noted that the Parish had submitted an objection which largely focused on the proposed provision of parking.

Rue de la Ville Bree – Resurfacing Works

It was noted that the contractor had been advised that the works needed further review and CA was awaiting further feedback. It was agreed that CA would send a further email.

Vallée de Rozel

It was noted that the yellow lines had been re-painted. It was agreed to discuss the one-way system with the Traffic Section of Infrastructure & Environment.

4. Rue de la Genestiere

It was noted that the CA had been contacted by a Parishioner concerned that recent works undertaken on a property on Rue de la Genestiere might impact road visibility. The Committee agreed that this was a Planning issue and should be referred to the relevant department accordingly.

5. Road Resurfacing Works - Update

It was noted that the majority of road resurfacing works had now been completed although there were outstanding queries for La Rue de la Vignette and Rue de la Ville Bree. Unfortunately the works for La Longue Rue had been delayed by a couple of weeks but it was envisaged these would commence within 2 to 3 weeks. It was noted that CA had requested the contractors to advise the residents about the delay.

6. La Rue de la Vignette – Drain Cleaning

It was noted that the Parish of St Saviour had enquired whether St Martin wished them to undertake the drainage cleaning for La Rue de la Vignette. This was particularly pertinent given the recent issues that had arisen in the locality and the fact that the Parish of St Saviour was already cleaning drains in the immediate vicinity. The Committee was advised of the estimated costs for the service and agreed to undertake a site visit prior to making a decision.

7. Budget Update

The Committee reviewed the expenditure to date and queried whether the fuel costs had been split 50:50. CA was requested to clarify with the Accounts Manager. It was noted that overall the remaining budget for the financial year amounted to £52,200 less £800 allocated for weed control.

8. Visite Royale

The Committee discussed the arrangements for the Visite Royale in 2026 and requested CA to provide a list of former attendees and clarify the Court's lunch venue.

9. AOB

Potholes

It was noted that there was a large pothole at the beginning of the Parish path by La Huterie and another located along Rue de la Bachauderie by Le Picachon. DW agreed to contact the former owner of La Huterie to clarify responsibility for the maintenance of that particular area as it also formed part of the driveway to the property.

Site Visit Notes:

Rue de la Genestiere

Following the site visit it was agreed this was a planning issue.

Rue La Vignette – Drains

The Committee was of the view that the drains should be maintained by the Parish's own team.

Vallée de Rozel

It was noted that there were a lot of leaves in the gullies and CA was requested to ask the Parish Team to review.

- c. To clarify petrol costs for Committee – CA & Accounts Manager
- d. To provide list of former attendees to the Visite Royale and clarify the venue for the Court - CA
- e. To contact former owner of La Huterie regarding driveway maintenance - DW
